

Terms & Conditions for the Whittard x My Christmas PJs x Kathryn Burn (the “Prize Draw”)

1. Introduction

- a. The Prize Draw is organised and run by Whittard Trading Limited (“Whittard”), who can be contacted at First Floor West 25 Western Avenue, Milton Park, Abingdon, England, OX14 4SH.
- b. By entering this Prize Draw you agree to these Terms and Conditions (these “Terms”) and any decisions reached by Whittard are final and binding in all matters related to this Prize Draw.
- c. The Prize Draw starts at 10:00 BST on 4th December 2023 and ends at 23:59 GMT on 10th December 2023 (the “Prize Draw Period”).

2. Who can enter this Prize Draw?

- a. Participants must:
 - i. be a resident of, and have a postal address in, United Kingdom; and
 - ii. be aged 18 or over.
- b. The Prize Draw is not open to directors, members, partners, employees, agents or consultants of Whittard, My Christmas PJs, Kathryn Burn or any person who directly or indirectly controls or is controlled by Whittard or My Christmas PJs, or any supplier of goods or services in connection with the Prize Draw, or their spouses, life partners, business partners or immediate family members.
- c. By entering the Prize Draw you hereby warrant that all information submitted by you is true, current and complete. Whittard reserves the right to verify the eligibility of all participants and disqualify a participant for submitting false information.

3. How does the Prize Draw work?

- a. No purchase is necessary to enter the Prize Draw and entry is free.

- c. Each participant must enter with a valid email address. As part of their Entry, a participant has the opportunity to make additional entries when completing the entry form by: (i) following Whittard of Chelsea on Instagram (@whittardofchelsea1886); (ii) following Whittard of Chelsea on TikTok (@whittardofchelsea1886); (iii) following My Christmas PJs on Instagram (@mychristmaspyjamas). Each follow will be counted as an additional Entry. Such additional Entries are not required to take part in the Prize Draw.
- d. All Entries must be received by Whittard during the Prize Draw Period or they will be void. Whittard will not accept responsibility for:
 - i. Prize Draw Entries that are lost, mislaid, damaged, or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - ii. any change in dates, times or cancellations or other arrangements that may prevent a winner from accepting, taking or using a prize.
- e. On 11th December 2023, one winner will be selected at random for the main prize, using a random computer-generated process, from all valid Entries received.
- f. The winners will then be notified on or after 12th December 2023 via Email (“Notification”).
- g. The Prize must be claimed in accordance with the instructions in the Notification message, within 72 hours of the Notification (the “Claim Period”). In order to receive their Prize, the winner will also need to provide Whittard with any further information requested by Whittard in accordance with the instructions set out in the Notification within this Claim Period. Failure to claim the Prize in accordance with the instructions in the Notification within the Claim Period will result in the forfeit of the Prize and an alternative winner will be chosen.
- h. The winner may be required to provide Whittard with proof of identification in order to verify compliance with the eligibility requirements for the Prize Draw.

- e. Any personal data collected from the winner and provided to My Christmas PJs will be for Prize redemption purposes only.
- f. The winner's surname and county will be made available. The winner will have the right to object to this information being published or to request a reduction in the amount of information being published. Whittard may be required to provide this information to the relevant regulatory authorities.
