# Terms & Conditions for the Whittard x Sandals Draw

# (the "Prize Draw")

## 1. Introduction

- a. The Prize Draw is organised and run by Whittard Trading Limited ("Whittard"), who can be contacted at First Floor West 25 Western Avenue, Milton Park, Abingdon, England, OX14 4SH.
- b. The accommodation and excursion provider, Unique Vacations (UK) Ltd. ("Unique Vacations"), can be contacted at 2nd Floor, Nucleus House, 2 Lower Mortlake Rd, Richmond TW9 2JA
- c. By entering this Prize Draw you agree to these Terms and Conditions (these "Terms") and any decisions reached by Whittard and Unique Vacations, which are final and binding in all matters related to this Prize Draw.
- d. The Prize Draw starts at 12:00 BST on 30<sup>th</sup> September 2022 and ends at 23:59 GMT on 31<sup>st</sup> October 2022 (the "Prize Draw Period").

## 2. Who can enter this Prize Draw?

- a. Participants must:
  - i. be a resident of, and have a postal address in, United Kingdom;
  - ii. have a valid passport;
  - iii. and be aged 18 or over.
- b. ## 3. How does the Prize Draw work?

- a. No purchase is necessary to enter the Prize Draw and entry is free.

- d. Each Participant must enter with a valid email address. In addition to their Entry, a Participant has the opportunity to enter the Prize Draw by following Whittard of Chelsea (@whittardofchelsea for Facebook, @whittardofchelsea1886 for Instagram and TikTok) on Facebook, Instagram and TikTok when completing the entry form. Additional entries are not required to take part in the prize draw.

The accommodations will be in a deluxe room (one king size bed), inclusive of all meals, unlimited premium brand spirits, daily & nightly entertainment, an array of land and water sports activities, including daily scuba diving (where available for certified divers only), snorkeling, Wi-Fi in all rooms and public areas, resort gratuities, resort taxes and Sandals Resorts transfers to and from the designated resort's airport.

### Prize B:

Whittard to provide:

# Prize A and Prize B, collectively "the Prize".

- c. Unique Vacations shall be responsible for the provision of Prize A to the winner.

- b. Whittard will use your personal details to contact you for administrative purposes relating to this Prize

- d. Whittard will keep your personal information safe and will use your personal information in accordance with the privacy policy available on its website (<a href="https://www.whittard.co.uk/privacy-policy.html">https://www.whittard.co.uk/privacy-policy.html</a>).
- e. Any personal data collected from the winner and provided to Unique Vacations as the Sandals Resorts Accommodations Provider and Administrator of the Sandals Resorts Accommodations for redemption purposes shall be subject to the privacy policy of the worldwide representative of Sandals Resorts (available here www.sandals.com/terms-conditions. Unique Vacations will only use the personal data of the winner and travel companion for the purposes of administrating the Sandals Resorts Accommodations redemption, unless the winner and travel companion provide express consent signifying their agreement to any other processing or use of their personal data. ### m. Sandals Resorts COVID-19 Policy:

A respiratory virus, called Covid19 and its variants have been identified as the cause of an outbreak of respiratory illness and cases have been identified in other countries and the Caribbean. The Influencer can find updated information on the Centers for Disease Control's website. The health and safety of resort guests is a priority. Prior to entering the Designated Resort, all guests will be administered a notouch thermal scan to screen for fever. Anyone with any fever (≥38 C°/100.4 F°) will not be allowed to enter the resort until they are assessed by a nurse of doctor. The medical professional may recommend that a COVID-19 test be administered. With a positive test result the guests remains isolated in their room until the release criteria of the specific jurisdiction is satisfied. If negative the guests will be free to enter and enjoy the resort. Beaches Resorts reserves the right to implement other health, safety and COVID-19 protocols in its sole discretion. There is a risk in entry regardless of temperature checks, and all guests enter at their own risk and shall be advised as follows: If you experience any symptoms of any illness while at the Resort, please stay in your room and contact the Medical Center. Consultation charges will be waived. If you develop symptoms after leaving the Resort, see a doctor right away and advise the Resort. All guests shall further acknowledge and agree that they are fully aware of the contagious nature and effects of COVID-19 and voluntarily assume that risk and responsibility and further agree that they will release, indemnify and hold harmless UTC, the Designated Resort, the Brand, and their respective parent companies, affiliates, subsidiaries, insurers, directors, officers, employees, successors, assigns, agents and representatives, against any claims and/or damages whatsoever, including legal fees relating to any infection, transmission, health condition influenced or otherwise impacted or complication by COVID-19.

n. Travel Safety Warning: Guests are responsible for checking the travel and entry protocols for the destination that they are travelling to before they depart and ensuring that they fully understand and comply with any such protocols. For example, for some destinations, may require all guests to be vaccinated and/or to obtain a negative PCR COVID-19 test a certain number of days pre-travel and post travel to the UK. EVEN IF APPLICABLE LAW PROVIDES OTHERWISE, GUEST AGREES THAT ANY ARBITRATION OR LAWSUIT AGAINST ANY ENTITY UNDER THE UNIQUE GROUP AND/OR SANDALS RESORTS WHATSOEVER SHALL BE LITIGATED BY GUEST INDIVIDUALLY AND NOT AS A MEMBER OF ANY CLASS OR AS PART OF A CLASS ACTION, AND GUEST EXPRESSLY AGREES TO WAIVE AUTHORITY TO ARBITRATE CLAIMS ON A CLASS ACTION BASIS. IF GUEST'S CLAIM IS SUBJECT TO LEGAL PROCEEDING UNDER FOREIGN SELECTION AND CHOICE OF LAW PROVISIONS OF THE ACCOMMODATIONS, AMENITIES, TRANSPORATION AND OTHER PRODUCTS OR SERVICES TERMS AND CONDITIONS (AVAILABLE HERE: WWW.SANDALS.COM/TERMS-CONDITIONS/) THE GUEST FURTHER AGREES AND ACKNOWLEDGES THAT THE CLASS ACTION WAIVER IS MATERIAL AND ESSENTIAL TO THE PROCEEDING OF ANY DISPUTES BETWEEN THE PARTIES AND IS NON-SEVERABLE FROM THE AGREEMENT TO ANY CLAIMS HEREIN. VALIDITY AND EFFECT OF THIS CLASS ACTION WAIVER MAY BE DETERMINED ONLY BY A JUDGE OR COURT OF LAW. GUEST AGREES THAT THIS SECTION SHALL NOT BE SEVERABLE UNDER ANY CIRCUMSTANCES FROM THE FORUM SELECTION AND CHOICE OF LAW PROVISION SET FORTH IN THE TERMS AND CONDITIONS. GUEST AGREES THAT THE PARTIES REFERENCED IN FOREIGN SELECTION AND CHOICE OF LAW PROVISIONS OF THE TERMS AND CONDITOINS THAT MAY BE THE SUBJECT OF ANY CLAIM BY GUEST CAN RECEIVE IMMEDIATE JUDICIAL ASSISTANCE TO ENFORCE THIS CLASS ACTION WAIVER.
